Overview

Box 5 is a checkbox indicating whether the distribution came from an HSA, Archer MSA, or Medicare Advantage MSA. 2 It does not report the account's fair market value. While the form covers all three account types, the vast majority of taxpayers will see it for HSA distributions. Each of the six codes in Box 3 of Form 1099-SA affects your taxes differently — here's what your code means and how to report it correctly.
